Introduction

Children are more curious when exposed to nature around them, and are more eager to touch and feel, then try to understand what they had interacted with. About Forest Exploration Camp

How to Get Started with Google Forms

If you don't have a Google account, signing up for one - for free - is your first step. Then head on over to Google Forms by going into your G Drive. To create a new Form from scratch, select the "New" icon, then "Blank" before picking "Forms." If you want more of an overview of options, such as templates, go directly to your Forms link here.

In addition to "Blank," there is a selection of prepopulated options. Scroll down in Education for the most relevant. This includes options such as a quiz, assessment, worksheet, and more.

If you're signed into Google Classroom with your college, this may look a little different. Options are broken down into "Your college department" and "General." The former are pulled in from your linked account if you have Google Classroom set up with your Google account. The rest are the generic offerings from Google.
